Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 15th day of May, 1962, I found the Center South 1/16 corner of Section 26 which was evidenced by one remaining bearing tree from a survey by registered Land Surveyor J. A. Gjelhaug in 1937, a plat of this survey is filed in the Forest Supervisor's Office, Chippewa National Forest, Cass Lake, Minnesota.

Jack Pine 6" S20°W 4 links (2.64') (Now a 9" Jack pine S20°W 2.64' scribed SC 1/16 S BT)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5 foot long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:
