







 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
 I further depose and say that on the 10th day of May, 1966, I found the Quarter corner of Sections 2-3 which was evidenced by G.L.O. resurvey of 1933 a set iron post 3 feet long by 1 inch in diameter with brass cap marked  
 Oak 5 inch S8°W 36 lks or 23.76 feet - Now a 13 inch S8°W 24.35 feet - rescribed 1/4 S3 BT. S3 | 1/4 S2  
 Pine 30 inch S75°E 15 lks or 10.1 feet - Now a pine stump S64°E - scribe visible. 1933  
 White Pine 30 inch S25°W 30 lks or 17.5 feet - Now a blown down pine S28°W - scribe visible.  
 and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap.
