



William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of May, 1966, I found the East 1/16 corner of Sections 12-13 which was evidenced by G.L.O. survey of 1933

a set iron post 3 feet long by 1 inch in diameter with brass cap marked E 1/16 $\frac{S 12}{S 13}$ 1933

Tamarack 5 inch N30°E 40 lks or 26.40 feet - Now a Tamarack stump at bearing and distance - scribe visible.

Tamarack 5 inch S60°E 38 lks or 25.08 feet - Now a Tamarack stump at bearing and distance - scribe visible.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap

from which reference or witness monuments are located in the manner following:

Tamarack 6 inch N74°W 40.7 feet - scribed E 1/16 S12 BT.

Tamarack 6 inch N35°W 21.3 feet - scribed E 1/16 BT.

Steel sign post 72 inches long with signs 54-2 and 54-4 attached due East 4.5 feet.

All reference bearings are true bearings.
