





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 12th day of May, 1966, I found the North East 1/16 corner of Section 23 which was evidenced by G.L.O. survey of 1933

a set iron post 3 feet by 1 inch in diameter with brass cap marked NE 1/16 S23 1933

Norway Pine 6 inch $N0^{15'}E$ 112 lks or 73.92 feet - Now a pine stump at correct bearing and distance - scribe visible.

Norway Pine 8 inch $S6^{1/2}E$ 157 lks or 103.62 feet - Now a 12 inch $S6^{\circ}E$ 103.6 feet with scribe visible - rescribed NE 1/16 S23 BT.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap.

from which reference or witness monuments are located in the manner following:

Jack Pine 8 inch $S87^{\circ}W$ 54.25 feet - scribed NE 1/16 S23 BT.

Set a 72 inch steel post with signs 54-2 and 54-4 attached due West 5.95 feet.
