





, being first duly sworn, deposes and says:

That I reside at Benidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of April, 1964, I found the section corner of Sections 33-34 which was evidenced by a monument set by G.L.O. resurvey in 1930 which is a 2" iron post with brass cap stamped:

Maple 8" N.11°E. 86 links (56.8') (now a 12" N.12°E. 50.8 feet scribe overgrown.

Maple 8" N.35 3/4°W. 70 links (46.2') (now a 9" at record bearing and distance with scribe overgrown.)
