That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 20th day of July, 1966, I found the Quarter corner of Sections 3 & 34 which was evidenced by remains of the G.L.O. resurvey of 1934 consisting of a 3 foot x 2 inch iron post with a 3 inch brass cap marked: and reset 6 inches below road surface.
